

## **BFF Indy Terms & Conditions, Waiver & Privacy Policy**

### **Effective January 1, 2026**

By registering for, attending, or participating in any BFF Indy event, online group, activity, or service, you ("Participant") agree to the following Terms & Conditions, Liability Waiver, Media Release, and Privacy Policy with **BFF Indy LLC ("BFF Indy," "we," "us," or "our")**.

These terms apply to **all** BFF Indy events, meetups, online platforms, partnerships, and experiences.

### **1. Eligibility**

You must be 18 years of age or older to participate in BFF Indy. By registering, you confirm that you meet this requirement.

### **2. Voluntary Participation & Assumption of Risk**

You understand and agree that participation in BFF Indy events may involve risks, including but not limited to:

- Physical injury
- Illness (including COVID-19 or other communicable diseases)
- Property damage or loss
- Emotional distress
- Risks related to travel, alcohol, fitness activities, beauty treatments, food, or third-party services

These services are **not operated or controlled by BFF Indy**. You agree that BFF Indy is not liable for any outcomes, results, injuries, dissatisfaction, or disputes related to these services.

#### **5. Medical & Fitness Disclaimer**

Some events may include physical activity, wellness treatments, or aesthetic services.

You confirm that:

- You are physically and medically able to participate
- You understand these services carry inherent risks
- You assume full responsibility for your health and safety

BFF Indy does not provide medical advice or medical services.

#### **6. Alcohol & Food Disclaimer**

If alcohol or food is served at an event:

- You consume at your own risk

- You are responsible for knowing your limits
- You are responsible for allergies or dietary restrictions

BFF Indy assumes no liability for any reactions, injuries, or consequences related to food or alcohol.
